It's easy to donate stocks, bonds and mutual fund shares to The Menninger Clinic Foundation. Follow these tips when donating securities:

1. Notify The Menninger Clinic Foundation of your plans by calling [713-275-5176](tel:713-275-5176) or emailing us at giving@menninger.edu. We will require your name and address, as well as the type of security and number of shares to be donated. This will ensure that when the shares are transferred, we recognize the source of the gift and may acknowledge your generosity promptly.
